At SeniorsPlus, the fiscal year runs from July 1 – June 30. Therefore, the reporting in this annual report ends June 30, 2020, when we were only a few months into the pandemic. Leaving out the rest of 2020 feels a bit like falling asleep thirty minutes into a movie and then having to give a review of it.



So while the statistics presented in this report are limited to fiscal year 2020, much of the conversation will cover the overall impact this momentous year had on our community and SeniorsPlus.

Client isolation is a constant worry at SeniorPlus and the pandemic brought that concern to new heights. At the invitation of the US Senate Special Committee on Aging, on June 11 via Zoom, Betsy Sawyer-Manter, President and CEO of SeniorsPlus, testified on isolation, describing how SeniorsPlus had worked to mitigate the effects of social isolation during COVID-19.

SeniorsPlus offers concrete, unbiased advice and services while being a reassuring presence for so many members of our community, especially as they confront the challenges posed by the pandemic.

We are grateful for the support of our dedicated staff as well as our donors, volunteers, businesses, and grantors; people like you who ensured the financial stability of SeniorsPlus and the health of our community during this difficult year.

A Message from the President and CEO



The doors at 8 Falcon Road closed in March 2020, but the work of SeniorsPlus continued, unseen but steady. Our clients depended on us and we went into overdrive to ensure their needs were met.

Challenges are funny things. You can retreat, or you can embrace them. The work of SeniorsPlus is often lifesaving. From Meals on Wheels, to care coordination, to benefits enrollment, to just answering calls, we are there for our community. We have to be. Pandemic or no pandemic.

Faced with an all-new and expanded homebound population, Meals on Wheels (MOW) almost doubled its meal production while also offering delivery of shelf-stable food and pet food. Following CDC guidelines, drop-and-go delivery, followed by a friendly check-in by phone, was employed.

Educational programming went virtual as we educated generations about Zoom, sometimes providing the necessary iPads and other technology. Medicare counseling, benefits enrollment, and care coordination were also handled remotely.

Meanwhile, new programs were introduced. Our Friendly Caller program, to check in on clients weekly to reassure them they were not alone, was created. After receiving a three-year Dementia Capable Maine (DCM) Administration for Community Living Demonstration Grant, we launched innovative dementia-support services and programs.

We continue to follow the CDC guidelines. But we do miss seeing our clients in person and are hopeful that the coming year will afford the return to safe, in-person interaction.







Statistics

We served 14,000 individuals and fielded 195,000 phone inquiries.

10,898 clients received information and assistance from staff in Community Services.

562 participants attended educational sessions.

162,303 meals were provided to 1,691 clients.

238 caregivers received support.

1,425 people received Medicare enrollment advice and 4,135 people received advice on benefits that may help them remain at home.

Medicare counselors helped save 234 clients a minimum of \$781,179 through Medicare Savings Programs.

187 volunteers served 20,334 hours, with a wage value of \$457,519.

SeniorsPlus had a total of 122 full- and part-time employees.

346 employers and 617 employees were served by SPLLC.

617 clients in Androscoggin, Oxford, and Franklin counties and an additional 4,445 clients statewide received Care Coordination services.

96% of clients reported that they were able to remain at home longer due to care coordination.

212 Environmental Modifications, 58 Nursing Facility Respite stays, 56 Assistive Technology devices, and more than 800 Emergency Response Systems were coordinated by Atypical Services.
